Expert Talks/Workshops/Trainings

- Expert Talks (Meetup) is a 2-3 hour interactive event where two or three expert speakers make a presentation on a current issue related to innovation, answer the questions of the participants, and chat with the participants directly at the end of the event. Participation is free and open to anyone who registers. Talks are usually held in the evening (between 18.00-21.00), thus enabling the participation of professionals working during the day. Although the number of participants varies according to the subject of the event, it is usually held with the number of participants in the band of 40-80 people. Trainings and workshops cover specific events related to advanced technologies or application areas in the context of financial innovation. (Due to Covid-19, these activities are carried out via Zoom)
- In addition, the activities organized by the members of the Association are actively supported by the Association and announced to the members.



Working Trips – Online Matching Events


- Fintech Working Trips are meeting series in which fintech startups, technology providers and financial institutions from Turkey and other regions participate to come together with their counterparts and potential customers in the visited countries. Each working trip has a two-day program which includes visits to institutions and companies, as well as a half-day matching event. (Due to Covid-19, these activities are carried out via Zoom)
- Working Trips are designed to enable participants to better understand the fintech ecosystem and market opportunities of the visited country as well as to help them meet and collaborate with stakeholders, regulatory agencies, acceleration programs, initiatives, and financial institutions in that country.



- Istanbul Fintech Week is an international event and a platform in which FINTR is positioned as the strategic partner where discussions on main industrial topics and technology verticals in fintech and latest innovation topics are held with the contribution of entrepreneurs, investors, professionals, managers and practitioners from all around the world who also evaluate collaborations. In the online event held in 2020, all kinds of networking opportunities were presented in digital environment. Volunteer Supports


- Advisory Board: It is a consultation board consisting of people who will support the association's vision, strategy and works with their experiences.
